### **A30 Crowlas eastbound resurfacing and speed reduction scheme**

Highways England operates, maintains and improves England's motorways and major A roads. I'm writing to let you know about works in your area.

#### **The works**

Following consultation with local representatives, this scheme has been designed to improve safety in Crowlas by reducing speed through the village. Ahead of the main speed reduction works we'll resurface 115m of the eastbound carriageway, at the approach to the junction with the B3309. Following this, we'll install signs and road markings to reduce the speed limit from 40 mph to 30 mph through the village and 220m west of the village. We'll enhance the village gateways to emphasise the new lower limit to traffic.

The work will take place in 2 phases:

#### **Phase 1 - eastbound resurfacing**

**5 and 6 August 2020** – Work will take place over the course of two nights. We'll begin work at 7pm in the evening and remove traffic management by 6am the following morning. On 5 August there will be some noise disturbance whilst the road surface is planed off and replaced, we aim to complete this by 11pm. On 6 August we'll replace high friction surfacing, lining and road markings. All work will be carried out under lane closures with 3-way temporary traffic lights in place. During this time there will be no access to/from the B3309, a locally signed diversion will be in place. Please note: some road markings will not be reinstated until phase 2.

#### **Phase 2 – speed reduction works**

**September 2020** - Work will take place overnight between the hours of 7pm and 6am the following morning, with noisiest works being completed by 11pm. We'll replace and install additional signage and update road markings. We'll also remove some lamp columns from the western approach to the village and enhance the village gateway posts to accentuate the new reduced speed limit through the village. Work will be carried out

under lane closures with temporary traffic lights and a convoy system in place. Access for residents will be maintained at all times via our gatemen, although there may be a short delay depending upon our stage of works.

Please accept our apologies in advance for any inconvenience these works will cause, we'll make every effort to ensure the impact on the local community is kept to a minimum. We always aim to work to the programme, however unforeseen circumstances, or adverse weather may mean changes to it. We'll keep you updated of changes in the programme via advance roadside warning signs.
